EXCLUSION OF LIABILITY, RELEASE AND ASSUMPTION OF RISK – ALL MEMBERS

I, _____ being a member of the Top Sportsman Association, certify that the particulars on my membership application form are true and correct in every particular, to the best of my knowledge and belief.

I have read and understood the Racing Rules for participation in drag racing events in Australia, and also the Rules of the Top Sportsman Association, and agree to be bound by them and the provisions of the Competition Rules of the Australian National Drag Racing Association Inc (ANDRA).

In exchange for being able to become a member of the Top Sportsman Association, and also enter, attend or participate in the Top Sportsman Class at any drag racing event in Australia, I agree:

- to release all members and office bearers of the Top Sportsman Association, ANDRA, promoters, sponsor organisations, land owners and lessees, organisers of the event, their respective servants, officials, representatives and agents (collectively, the "Associated Entities") from all liability for my death, personal injury (including burns), psychological trauma, loss or damage (including property damage) ("harm") howsoever arising from my participation in or attendance at any drag racing event, or any other event (whether it be a social event, meeting of the Association, or otherwise) organized by the Top Sportsman Association except to the extent prohibited by law;
- that the Top Sportsman Association, ANDRA and the Associated Entities do not make any warranty, implied or express, that the event services will be provided with due care and skill or that any materials provided in connection with the services will be fit for the purpose for which they are supplied; and I attend or participate in the event at my own risk.

I acknowledge that the risks associated with attending or participating in the Top Sportsman Class at a drag racing event include the risk that I may suffer harm as a result of:

- motor vehicles (or parts of them) colliding with other motor vehicles, persons or property;
- acts of violence and other harmful acts (whether intentional or inadvertent) committed by persons attending or participating in the event; and
- the failure or unsuitability of facilities (including grand-stands, fences and guard rails) to ensure the safety of persons or property at the event.
